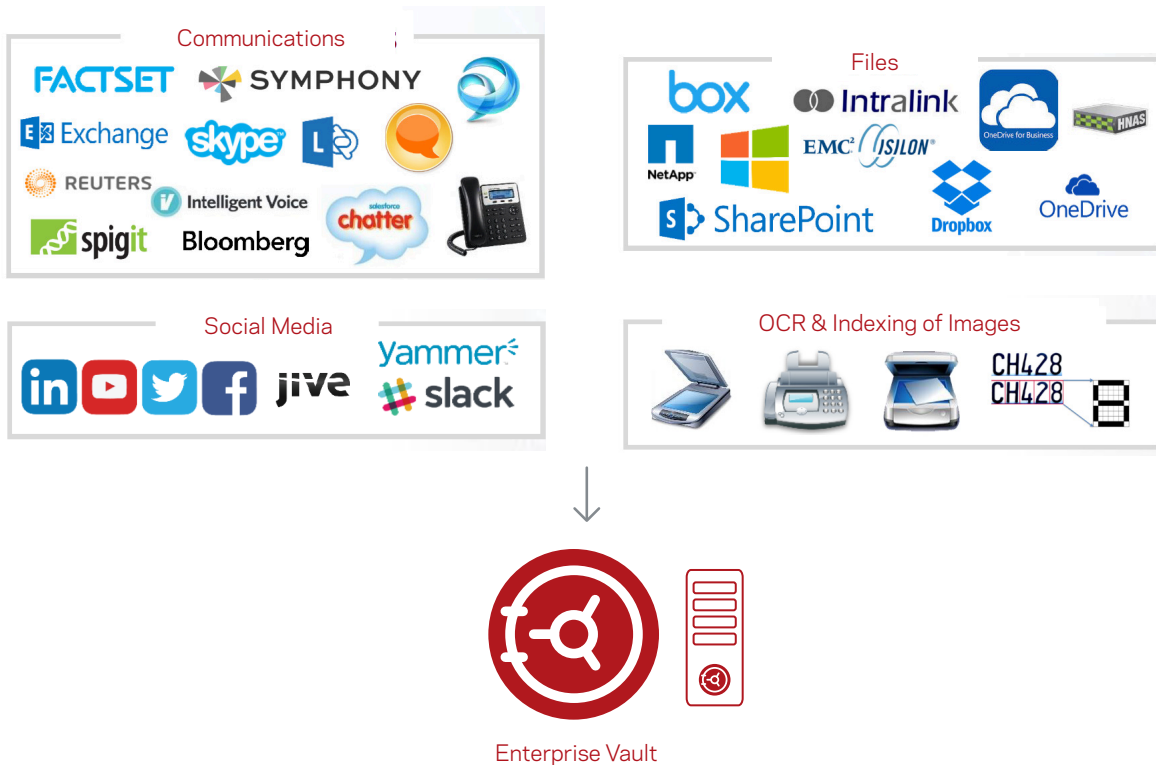

SIMPLE EMAIL ARCHIVING WITH ENTERPRISE VAULT SMTP ARCHIVING

Enterprise Vault SMTP archiving helps simplify the capture of journal messages from various platforms, such as Office 365, without the need to put users on litigation hold. Because Office 365 can directly journal messages to Enterprise Vault via SMTP, customers no longer have to maintain Exchange Servers on premises for the purposes of journal archiving. Messages received are then archived, indexed, classified and made available for search, compliance, and eDiscovery purposes.

Enterprise Vault SMTP archiving offers various configurations that allow you to archive for discovery purposes or end user access to data:

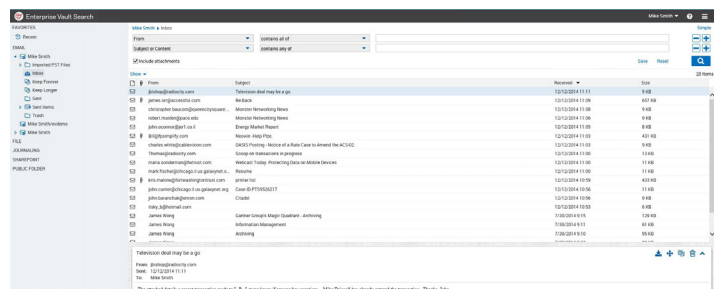
- SMTP Journaling supports archiving all messages sent to the Enterprise Vault SMTP Server in one or more journal archives.
- Selective SMTP Journaling enables you to archive only messages to or from specific addresses into a specified archive.
- SMTP Mailbox Journaling extends Selective Journaling further to store all messages to and from specific addresses in an archive that is exclusive to that address.

Give users the power to set retention, manually classify items and move items within their archive.

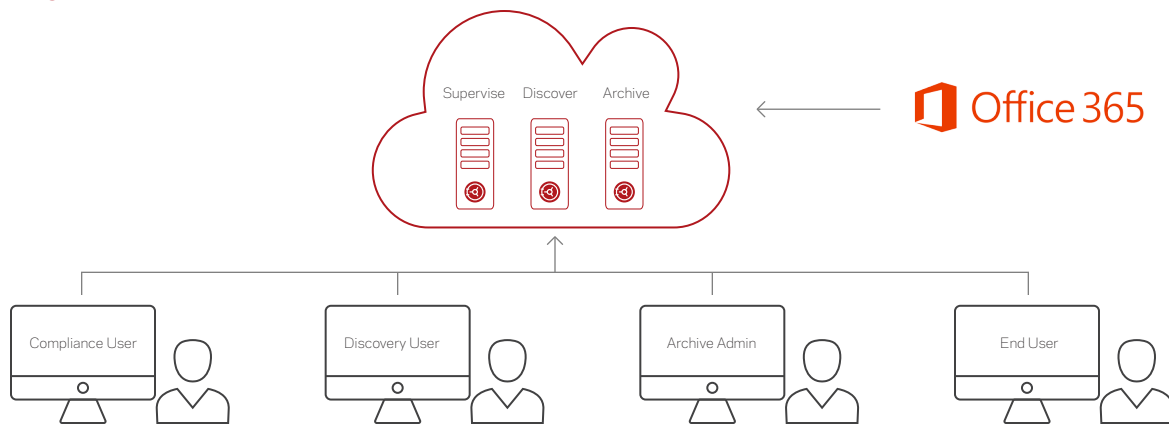
